## **A WORD ABOUT CAMPUS SAFETY**

One of the most important aspects of our institution is the quality of safety offered by the University. USN is dedicated to providing a safe learning environment for our students, faculty and staff. The Facilities Unit strives to uphold an environment where civility is practiced, diversity is respected, and safety is ensured. To fulfill this goal, the Facilities Management Unit encourages campus community involvement, problem-solving and interactive relations. We welcome suggestions that will enhance our services and look forward to fostering a safe and secure environment.

## **CLERY ACT OVERVIEW**

### **Background**

The current Clery Act is the latest iteration of a law first passed by Congress in 1990 as part of the Higher Education Act, the “Student Right-To-Know and Campus Security Act of 1990.” Amendments enacted in 1998 renamed the “Student Right to Know and Campus Security Act” as the “Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act,” expanded the campus responsibilities for recording crime statistics, added people from who colleges must collect statistics, and revised reporting methods and deadlines. The Department of Education regulations implementing the 1998 amendments to the Clery Act were adopted November 1, 2000. The 1999 regulations define and clarify reporting obligations for various geographic locations, clarify responsibilities of counselors, add new categories of crimes to be reported and new policies to be disclosed. It also clarifies how to compile and describe crime statistics, change the date of disclosure of the Annual Security Report to October 1, and require certain institutions to maintain a publicly available crime log.

### **University Policy**

Pursuant to the Campus Crime Awareness and Campus Security Act of 1990, and the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act of 1998, The University of Southern Nevada is pleased to provide security statistics to any requestor. They can obtain the report via the internet at our website [www.usn.edu/campus-safety](http://www.usn.edu/campus-safety) or through the Facilities Management Unit. The following notice will be provided for (current and/or incoming) students and employees:

#### **RIGHT TO KNOW**

“As provided by the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act of 1998, you are entitled to request and receive a copy of University of Southern Nevada’s Annual Security Report. This report includes statistics for the previous three years concerning reported crime that occurred on campus; in certain off-campus buildings or property owned or controlled by The University of Southern Nevada; and on public property within, or immediately adjacent to and accessible from, the campus. The report also includes institutional policies concerning campus security, such as policies on drug use, crime prevention, the reporting of crimes, sexual assault, and other matters. ## **OUR CAMPUS**

### **Facilities**

The University of Southern Nevada currently occupies seven facilities, four in Southern Nevada and one in South Jordan, UT. The main campus facility is a 100,000 square foot building at 11 Sunset Way in Henderson, Nevada. Recently, the University has taken occupancy of two buildings located less than one-quarter mile from the main Henderson campus. One building will be used for classroom, office, and clinic space for the College of Dental Medicine. The second building will be used for classroom and office space for the MBA program. The third building is for administration offices.

In December of 2006 the University completed construction of a two-story, 119,000 square foot facility in South Jordan, Utah (just south of Salt Lake City). The facility in South Jordan houses an extension of the Pharmacy Program and Nursing Program and will allow for the eventual expansion into other programs. Fully developed space includes three classrooms, a library and learning resources center (LLRC), student commons, laboratory and necessary offices for the faculty and staff. The design of the South Jordan classrooms was based on the large classrooms of the Henderson Campus with the most current technological upgrades and appointments.

### **Population on Campus**

#### **Students**

Currently, the Henderson campus has 621 students attending classes in the fields of Pharmacy, Nursing, Advanced Dental and MBA. Our South Jordan Utah extension program has 274 students attending classes in the fields of Pharmacy, Nursing and MBA.

#### **Employees**

At the present time, the University employs 119 full-time and 6 part-time employees on the Henderson Campus. Our South Jordan Campus has 32 full-time and 3 part-time employees. Visiting faculty and other guests are present on a daily basis.

#### **Housing**

There is no student housing available. Students are required to arrange for their own living accommodations.

## **PARKING**

### **Student Parking**

Henderson Campus – Free student parking is available by permit only on the east side of the building on a first come first serve basis. Students are issued a parking permit during orientation. The parking permit must be displayed on the bottom left hand corner of the windshield. The University of Southern Nevada recently leased two additional buildings at 4 Sunset Way. There are 100+ additional parking spaces available at the NW corner of TV5 and Sunset Way. All spaces available to USN are marked accordingly.

There are students who study on the main campus or in library in the evenings. If you are one of those students and park in the overflow please consider moving your vehicle to the main campus before dark.

South Jordan Campus – Free student parking is available on the north, west and south end of the building. This allows students to access the building closest to student classrooms and the commons. The parking permit must be displayed on the bottom left hand corner of the windshield.

### **Handicap Parking**

Henderson / South Jordan Campus – These facilities meet the ADA requirements.

### **Assigned Parking**

Henderson Campus - Covered reserved parking spaces for employees are available on the West side of the campus building on a first come first serve basis, as posted. Employees receive an appropriate parking permit, which must be visible in the left hand corner of their windshield.

South Jordan Campus - Has reserved parking on the north side of the building. Employees receive an appropriate parking permit, which must be visible in the left hand corner of their windshield

### **Visitor Parking**

Henderson / South Jordan Campus - In addition, there are "Visitor" spaces available for outside guests, which may not be used by University of Southern Nevada employees or students.

### **Escorts**

Employees and students who plan on remaining on campus late into the evening to study or work should move their vehicle to a location that is closest to the entrance they plan on exiting. This will allow our security guards to provide better protection for our students and staff. It is not advisable for employees or students to walk alone during the evening hours. If you feel you need an escort to your vehicle, the on-site security guard can monitor you from the front entrance while you are walking to your vehicle.

### **Bicycles**

Henderson Campus - A secure bicycle rack has been installed in front of the student commons. It is recommended that a U-LOCK be used to secure both the bicycle frame and wheels to the rack.

South Jordan Campus - A secure bicycle rack has been installed on campus near the student commons.

## **CAMPUS SECURITY AND UNIVERSITY POLICIES**

### **Security Service and Hours**

For your protection, our campus is protected by a professional security service. Security guards are on-site at the main campus from 7:30 a.m. – 11:00 p.m. except for weekends, holidays and school breaks. All other buildings have security in accordance to the class schedules. Additional security is provided for special events if scheduled at a time other than regular security hours.

The University does not have a memorandum of understanding with the local police department for patrol. There are no public streets that are thoroughfares through any of our campuses. The PD's do supply crime statistics each year for the Annual Security report.

### **Campus Access and Maintenance**

Since both the Henderson and South Jordan facilities are small campuses, our daily population is undersized compared to larger Universities. Having a smaller population is conducive to keeping our crime rate very low. The nature of the study, and service, conducted at USN requires that our facility be open to our students during normal business hours. Students should always be alert and aware of their surroundings and exercise common-sense safety precautions.

Facilities and landscaping are maintained in a manner that minimizes hazardous conditions. Our contracted Security Officers regularly patrol the campus and report malfunctioning lights or other unsafe physical conditions to facilities management authorities for correction. In addition, USN invites staff/students to report any physical hazards. Our maintenance team is constantly pinpointing any potential safety issues such as areas needing additional lighting, trees or bushes needing trimming to reduce shadows, or potholes and/or other obstacles.

It is essential that staff, and faculty, cooperate to keep closed facilities locked. To ensure that unauthorized individuals do not enter campus buildings DO NOT prop doors open or leave doors unlocked if you enter after hours. DO NOT open the door for individuals you do not know. In addition, protect the security of campus keys/access badges, and report immediately the loss or theft of keys/access badges. All employees may use their identification card to gain access to campus facilities after regular business hours. All Facilities employees will follow the proper procedures to maintain security at all times.

In addition to the badging card access system, the university has security cameras in place. This allows the Facilities Management team to monitor activities on campus if necessary.

### **I.D. Badges**

All students, faculty, and employees are issued identification badges, which must be worn at all times. Any unit having visitors are required to obtain a visitor's badge at the main reception desk in the front lobby. All visitors' badges must be returned to the front desk.

### **Keys**

The Facilities Management Unit keeps a record of all keys used in all locations of the University. A list of keys held by each employee is also on file in Human Resources.

## **PA System & Fire Alarm System**

The Henderson campus has a fire alarm system in place and if an alarm is activated all occupants are to evacuate the building to their designated Assembly Areas outside the building for roll call. Additionally a PA (Public Address) system has been installed through the main campus and verbal instructions can be relayed in the event of a crisis.

The South Jordan campus has a fire alarm system in place which follows the same protocol for evacuation as the Henderson campus for evacuation.

A crisis management plan has been written for the University and is in a continuous process of planning prevention, response and recovery in the likelihood of a crisis affecting the campus community.

## **Security Officers**

The University of Southern Nevada contracts with an outside professional security service. There are two (3) full-time security guards monitoring the Henderson campus and two (2) full-time security guards monitoring the South Jordan Campus. This service is provided during normal operating hours. Additionally, there are drive-by security units that check both campuses several times per evening, weekends, and holidays. Security officers are given written instructions on security policies, procedures, and any special event that may be occurring.

When an actual or suspected crime occurs, on campus property, including the parking lot, students/employees should report the incident to the Facilities Management Unit or if after hours to the security guard on duty. If a situation develops in which the student fears for his/her safety, he/she should immediately call 911 (9-911 from a university phone). Students are encouraged to walk in groups when leaving campus after dark. Concerns regarding campus security should be directed to the University Facility Management Unit. When university sanctioned events occur on the weekends, a security guard is present for the duration of the activity. Facilities Management is responsible for the administration of the security service. Although our officers may not arrest anyone they may restrain them until the police arrive on the scene.

The University libraries are open late for the convenience of our students. In view of that fact, the University provides two-way communication radios to the security officers and library staff. This allows our library staff and security officers to communicate rapidly in any emergency that may arise.

## **Reports**

The Facilities Management Unit contracts with a professional security service in keeping up-to-date on security procedures. Security guards keep a written log of the day's events and they are submitted to the Facilities Management Unit. All criminal activities are noted and added to the Current Crime Statistics printed in this report.

USN retains daily logs of any crime that occurred within the patrol jurisdiction of the contracted security company designated by the University.

Dates of the crimes are recorded as well as the nature, time, general location of each crime, and the disposition of the complaint. Crime logs for the last 60 days are available in the Facilities Management Unit for inspection during normal business hours. The last three years of security documentation is stored on site as per Clery Act Requirements. Any questions or concerns regarding security should be submitted in writing (for mailing address; see website [www.usn.edu](http://www.usn.edu)) or call the Facilities Management Unit at extension 2037 (from a campus phone) or (702) 968-2037. This information is reported to the Office of Postsecondary Education Institutions annually.

## **Crime Reporting Policy Procedures and Responses**

Crime is reported via Incident Reports and to the local police department if necessary. Any crime that could have an effect on the campus population will be reported via an “Alert” to all of the campus community

### **Timely Notice Requirement**

The University shall, in a manner that is timely, and will aid in the prevention of similar crimes, report to the campus community on crimes that are:

- ❖ Listed in the Clery Act
- ❖ Reported to campus security authorities as identified by the school or to local police, and are considered to represent a threat to others. (If this includes police contact, a warning will be issued within 2 days. The date, time, and definition of the crime will be reported.)

If students or staff reports a serious incident to security, they in turn will immediately notify the Facilities Management unit. A Campus Safety Alert will be issued by the Vice-President of Facilities or designee if deemed necessary. The timing of the notification shall be based upon whether the incident is considered a serious or continuing threat to students or staff. The Alert will be done electronically and/or notices will be posted on campus by designated staff.

### **Evacuation Policy and Procedures (Crisis Management Plan)**

The University of Southern Nevada Crisis Management Plan was prepared by the University Planning, Priorities and Resources Committee. This document sets in motion a continuous process of planning, prevention, response, and recovery to crisis events that have the highest likelihood of occurring and the greatest potential impact on the campus community. Additionally, this plan establishes a Crisis Management Team (CMT) composed of University Administrators and other essential personnel to facilitate USN’s response to any crisis affecting the University.

For this plan, “crisis” shall be defined as an event, which is often sudden or unexpected, that disrupts the normal operations of USN or its educational mission and threatens the well-being of personnel, property, financial resources, and reputation of the institution.

The Crisis Management Plan is intended to establish a basis for the organization, policies, procedures and management of resources in order to respond to crisis events with the goals of:

- Minimizing any injury or loss of life;
  - Preserving and protecting property (both personal and institutional);
  - Restoring critical functions to the university; and
  - Preserve the reputation of the institution.

### **Fire Safety Policies and Procedures (Residential Facilities)**

USN does not have residential facilities; therefore this requirement by Clery does not apply.

### **Daily Log Requirement (Crime Alert)**

## *Safety and Security on Campus – USN*

The log will record:

All crimes reported to the security department unit, indicating:

- ❖ The nature of the crime;
- ❖ The date, time, and general location;
- ❖ The disposition of the complaint (if known);
- ❖ These log entries or updates will be made within 2 business days (this may be withheld if jeopardy exists) but only to the extent of the length of time damage is likely to occur;
- ❖ The most recent 60 days are immediately available to the public, older logs must be produced with 2 days; and
- ❖ The information may be provided by electronic format.

### **Reporting Crime**

University of Southern Nevada encourages prompt reporting of any crime. Please report to the nearest security officer or to the Facilities Management unit at extension 2037 (from a university phone) or (702) 968-2037.

### **Confidentiality**

If confidentiality is required, Students may contact their Student Advisor and Employees may contact Human Resources at extension 1611 (from a campus phone) or (702) 968-1611.

### **Missing Person Policy and Procedures (Residential Facilities)**

USN does not have residential facilities; therefore this requirement by Clery does not apply.

### **Weapons Policy**

Security personnel are not permitted to carry lethal weapons while on duty. Only appropriate governmental law officers are permitted to enter the campus armed. Possession of a weapon (Penal Code 626.9) prohibits bringing a firearm, knife or dangerous weapon onto a campus including the University of Southern Nevada.

### **Off Campus Activities Policy**

Any University sponsored function that occurs in off-campus areas will be monitored by approved staff. Any incidents that are deemed security issues will be reported to the Facilities Management Unit.

**Note:** The Henderson Police Department combines crime statistics for private homes, as well as with public property.

### **Drugs/Controlled Substance Policy**

The University of Southern Nevada is committed to maintaining a drug-free campus and workplace in compliance with applicable laws. The unlawful possession, use, distribution, sale, or manufacture of controlled substances is prohibited on the University's campuses. Violation of this policy may result in appropriate disciplinary action.

### **Personal Counseling about Non-Academic Counseling Issues**

Students needing personal counseling services about non-academic issues (e.g., grief counseling, alcohol, substance abuse and mental health) should contact the Registrar/Director of Student Services. While these services are not provided by the University, the Registrar/Director of Student Services provides students with a confidential venue to voice concerns, ask questions and Student Services can work with the student to refer him/her to appropriate resources for additional assistance.

## **Hate Crime Policy**

Investigation of hate motivated crimes and incidents are a priority with the University. Our response is necessary to assure the community that racism and violence will not be tolerated, and that perpetrators of such crimes will be brought to justice. This policy provides guidelines for identifying and investigating reportable crimes and incidents and the resources to which victims can be referred for assistance.

### **Definitions of Hate Motivated Crimes and Incidents**

***Reportable Hate Motivated Crime:*** Any criminal act or attempted criminal act intended to cause physical injury, emotional suffering or property damage which is or appears to be motivated, all or in part, by race, ethnic background, national origin, religious belief, sex, age, disability, or sexual orientation.

***Reportable Hate Motivated Incident:*** Any non-criminal act directed at any person or group based upon any of the eight categories listed above.

***Motivation:*** Incentive, inducement, desire, emotion, or similar impulse resulting in some type of action.

***Race:*** Any group or class of individuals with common characteristics distinguished by form of hair, color of skin and eyes, stature, bodily proportions, etc., that are genetically transmitted to classify it as a distinct human type.

***Ethnic Group:*** Any group or class of individuals within a culture or social system that can be distinguished on the basis of variable traits including nationality, religion, linguistics, ancestry, tradition, attire, etc.

***Religion:*** A personal awareness or conviction of the existence of a Supreme Being, supernatural powers, or influences controlling one's own humanity or all nature's destiny.

## **Criteria for Reporting Hate Motivated Crimes and Incidents**

The following criteria are to be used in determining whether an incident is racially, religiously, or ethnically biased in nature, or based upon one's gender, disability, or sexual orientation. The list is not all-inclusive. In some cases, a common-sense approach must be used. If it looks like an incident motivated by bias based upon one's race, ethnic background, national origin, religious belief, gender, disability, or sexual orientation, it should be reported as such. Verification can be made later during the investigation. A criminal act may include any of the following:

***Burning cross or religious symbol.***

***Explosives*** perpetrated against person(s) because of their race, religion, ethnic background, etc.

***Bomb threats*** perpetrated against person(s) because of their race, religion, ethnic background, etc.

***Destroying, injuring property*** of another directed against person(s) or group(s) because of their race, religion, ethnic background, etc.

***Assault or battery*** which is directed at person(s) because of their race, religion, ethnic background, etc.

***Disorderly conduct*** is any communication, written or oral, directed at person(s) because of their race, religion, ethnic background, etc.

***Interrupting or disturbing religious, ethnic/cultural, political, or other meetings*** directed at person(s) because of their race, religion, ethnic background, etc.

***Possession of a firearm in proximity of public demonstration*** which occurs at public demonstration for racial, religious, ethnic, etc. purposes.

***Unlawful use of the telephone*** which is directed at person(s) because of their race, religion, ethnic background, etc.

***A non-criminal act or incident***, while not criminal, is done with the apparent intention to harass, intimidate, threaten, retaliate, create conflict, because of any person(s) race, religion, ethnic background, etc. The key criterion in determining whether or not any crime or incident fits into the definition of bias based upon race, ethnic background, national origin, religion, gender, age, disability, or sexual orientation is the motivation behind the incident. Reports of such incidents are taken because there is a potential for reoccurrence and/or escalation into a criminal act.

## **Reporting Hate Motivated Crimes and Incidents**

The University Facilities Management unit is responsible for collecting and reporting hate motivated crime statistics. Hate motivated crimes and incidents may be reported to the following locations:

Persons receiving a report of hate violence are urged to review the circumstances of the incident with the Facilities Management unit to ensure that an appropriate report is completed, the perpetrator is apprehended, the statistics are collected and disseminated, and the victim(s) is provided with assistance/referrals.

**How do these laws help?** Penal code violations punish persons who have violated the rights of others through the criminal court system. Civil remedies handled through the civil court system provide protection for victim(s) and provide damage money to those harmed by violence or threats. University sanctions can include: Expulsion, termination of employment, suspension, probation.

**Crime Policy** – Criminal activities and emergencies on campus are to be reported immediately by calling 9-911 (from a campus phone), and calling Facilities Management at ext. 2037 (from a campus phone) or (702) 968-2037. Criminal activities will be investigated and local law enforcement authorities will be notified as necessary.

## **CRIME PREVENTION & SAFETY TIPS**

### **Protecting Yourself on Campus and at Home**

- ❖ Keep your purse, wallet, or other valuables in a locked cabinet or drawer. Office thieves know where to look.
- ❖ Be aware of your surroundings and any signs that something appears to be wrong or out of place.
- ❖ Avoid walking alone, especially at night, unless absolutely necessary.
- ❖ Stay in well-lit areas.
- ❖ Exercise good judgment when walking, jogging or engaged in solitary activity, especially at night.
- ❖ Do not risk personal injury if someone forcibly attempts to take your wallet, purse, or property.
- ❖ Carry a whistle or personal alarm and use it when you feel threatened.
- ❖ Do not attach your ID to your key chain or mark your keys with your name and address.
- ❖ Do not carry extra credit cards or large sums of money.
- ❖ Keep automatic teller machine cards in a safe place; keep your PIN number secret. When possible, only use ATMs during the day.
- ❖ Lock or secure doors and windows when you are alone or asleep.
- ❖ Keep emergency numbers by your phone.
- ❖ Get to know your neighbors and share information about suspicious activities.
- ❖ Acquaintance Rape does happen. Learn the danger signs.
- ❖ Distance yourself from the misuse of alcohol / drugs.

### **Vehicle Safety**

- ❖ Immediately report thefts, as well as suspicious activity in University parking lots or near parked cars to Security or Facilities Management at extension 2037 (from a campus phone) or (702) 968-2037.
- ❖ Look into your car before getting in. Lock doors and roll up windows once inside for protection.
- ❖ Always have keys ready in hand not buried in a purse.
- ❖ Never pick up hitchhikers.
- ❖ Drive to a police or fire station or open place of business if you feel you are being followed.
- ❖ Do not stop to help occupants of stopped or disabled vehicles; continue driving to the nearest phone and call assistance for them.
- ❖ If your car breaks down, raise the hood then lock yourself into your car. If someone stops and offers you help, remain in your car and ask them to phone for help.
- ❖ Lock all doors after parking.
- ❖ Secure your car against theft/burglary with an electronic alarm, kill switch, “Club” or other theft deterrent.
- ❖ Keep a copy of your registration, title, and vehicle I.D. number in a safe place separate from your vehicle.
- ❖ Store your valuables out of sight.
- ❖ If your car is parked and not used regularly, check on it daily.

### **Bike Safety**

- ❖ Ride defensively with the traffic and use hand signals.
- ❖ Be considerate of pedestrians and drivers in vehicles.
- ❖ Keep your bike maintained – especially the brakes.
- ❖ Use a U-LOCK to secure your bicycle frame and wheels to a rack. Bikes locked with cables and small chains are easily stolen.

## *Safety and Security on Campus – USN*

- ❖ Report suspicious activity or loitering around bike racks. Thieves usually carry a hidden bolt cutter or other cutting tool.
- ❖ Never leave your bike unsecured even for a “moment”.

## **Sexual Assault Programs**

University of Southern Nevada will not tolerate sexual assault to any person, male or female, committed by a stranger or acquaintance. To the fullest extent possible, it is the policy of University of Southern Nevada to provide to any student, faculty, or staff member who is a victim of sexual assault, any treatment, support, or information and to encourage these victims to use the resources provided.

It is our obligation to direct our attention to the needs of the sexual assault victim and to try to protect all members of the campus community from potential sexual assaults. Support will be offered to victims along with referrals for treatment.

All incidents of rape will be made known in order to determine if the areas of hazard require extra security and/or attention from the Facilities Management unit. If the campus community is to be notified of the assault for safety reasons, the victim will be informed prior to such notification, and the victim’s identity will remain confidential.

If a sex offense occurs on campus the victim’s academic situation will be evaluated by the appropriate Dean or Program Director for further action if necessary. The accuser and accused have the same right to have others present during a disciplinary hearing. The accuser and accused shall be notified of the outcome of a campus disciplinary proceeding.

**If you are assaulted**

It is extremely important for you to seek help immediately by doing the following:

**Get to a safe place and call police 9-1-1 or 9-911 (from a campus phone).**

The police will take you to the hospital for proper medical attention and will make a report. All victims of rape are encouraged to seek medical attention as soon as possible. During your treatment, medical evidence will be collected. For this reason, it is of extreme importance not to change clothes, shower, bathe, douche or brush your teeth. Collecting of evidence is important; however, it does not require you to press criminal charges. This decision can be made later. If evidence is not collected immediately it may hinder your ability to press criminal charges should you choose to do so. It is the obligation of the medical provider to report the incident to the police. They will come to the emergency room where you are being treated to interview you. ## **VIOLENCE IN THE WORKPLACE**

The University’s goal is to maintain a safe environment in which to conduct our business and fulfill our mission. A climate of fear or intimidation will not be tolerated. University policy provides that:

Threatening behaviors, acts of aggression and instances of violence will result in appropriate responses, up to and including dismissal, expulsion or termination of employment, and the pursuit of civil and criminal penalties, as appropriate. Violence and threats of violence include, but are not limited to:

- ❖ any act which is physically assaulting;
- ❖ any substantial threat to harm;
- ❖ to endanger the safety of others;
- ❖ behaviors or actions interpreted by a responsible person as carrying the potential for violence and/or acts of aggression; or
- ❖ any substantial threat to destroy property.

It is the responsibility of every administrator, faculty member, staff member, and student to take any threats of violence seriously, and to report them to the appropriate resource. When confronted by an imminent or actual incident of violence, **call 9-1-1 immediately or 9-911 (from a campus phone)**. When presented with a threat of possible violence, action is recommended as follows:

- ❖ Threats by a students or staff should be reported immediately to the Facilities Management unit.
- ❖ Threats by a faculty member should be reported immediately to the Facilities Management unit and the appropriate Dean’s Office for consultation.
- ❖ Threats from others not affiliated as a student or employee should be reported immediately to the Facilities Management unit at extension 2037 (from a campus phone) or (702) 968-2037.

## **SAFETY IMPROVEMENTS**

The University anticipates making the following improvements during the next 24 months:

- ❖ Continued installation of card/key access system in strategic locations throughout the campus;
- ❖ Continued monitoring of security guard visibility and how it relates to crime deterrence;
- ❖ Continued exploration into enhanced security/alarm techniques; and,
- ❖ Expanded hours of professional security coverage.

## **CRIME STATISTICS**

An informed University community is a safety-conscious University community. The statistics in this handbook are provided to help keep you informed and aware about crime at the University of Southern Nevada sites.

### **Uniform Crime Reporting**

The following definitions will help you understand these statistics:

**Homicide:** The killing of one human being by another.

**Sex Offense—Forcible:** Any sexual act directed against another person, forcibly and/or against that person’s will; or not forcibly or against the person’s will where the victim is incapable of giving consent.

***Forcible Rape:*** The carnal knowledge of a person, forcibly and/or against that person’s will; or not forcibly or against the person’s will where the victim is incapable of giving consent because of his/her youth or his/her temporary or permanent mental or physical incapacity.

***Forcible Sodomy:*** Oral or anal sexual intercourse with another person, forcibly and/or against that person’s will; or not forcibly or against the person’s will where the victim is incapable of giving consent because of his/her youth or his/her temporary or permanent mental or physical incapacity.

***Sexual Assault with an Object:*** To use an object or instrument to unlawfully penetrate, however slightly, the genital or anal opening of the body of another person, forcibly and/or against that person’s will; or not forcibly or against the person’s will where the victim is incapable of giving consent because of his/her youth or his/her temporary or permanent mental or physical incapacity.

***Forcible Fondling:*** The touching of the private body parts of another person for the purpose of sexual gratification, forcibly and/or against that person’s will; or not forcibly or against the person’s will where the victim is incapable of giving consent because of his/her youth or his/her temporary or permanent mental or physical incapacity.

**Sex Offense—Non-Forcible:** Unlawful, non-forcible sexual intercourse:

***Incest:*** Non-forcible sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law.

**Statutory Rape:** Non-forcible sexual intercourse with a person who is under the statutory age of consent.

**Robbery:** The taking or attempting to take, anything of value under confrontational circumstances from the control, custody, or care of another person by force or threat of force or violence and/or putting the victim in fear of immediate harm.

**Larceny:** The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another.

**Vandalism:** To willfully or maliciously destroy, injure, disfigure, or deface any public or private property, real or personal, without the consent of the owner or person having custody or control by butting, tearing, breaking, marking, painting, drawing, covering with filth, or any other such means as may be specified by local law.

**Simple Assault:** An unlawful physical attack by one person upon another where neither the offender displays a weapon, nor victim suffers obvious, severe, or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration or loss of consciousness.

**Intimidation:** To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack.

**Aggravated Assault:** An unlawful attack by one person upon another wherein the offender uses a weapon or displays it in a threatening manner, or the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.

**Burglary:** The unlawful entry into a building or other structure with the intent to commit a felony or a theft. Included are attempts to commit burglary where force is employed, or where a perpetrator is frightened off prior to completing the crime.

**Theft:** The unlawful taking, carrying, leading, or riding away of property from the possession, or constructive possession, of another person.

**Motor Vehicle Theft:** The theft of a motor vehicle.

**Arson:** To unlawfully and intentionally damage or attempt to damage, any real or personal property by fire or incendiary device.

**Liquor Law Violation:** Violations of laws or ordinances prohibiting the manufacture, purchase, transportation, possession or use of alcoholic beverages (does not include driving under the influence).

**Drug Abuse Violation:** Violation of laws prohibiting the production, distribution, and/or use of certain controlled substances and the equipment or devices utilized in their preparation and/or use.

**Weapons Possessions:** Violation of laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, concealment, or use of firearms, cutting instruments, explosives, incendiary devices or other deadly weapons.

**An arrest means that the following has happened:**

## *Safety and Security on Campus – USN*

A law enforcement officer has detained an individual. The officer has the intention of seeking criminal charges against the individual for a specific offense(s); and a record is made of the detention.

**Detention** of an individual with the intent to refer the person for “discipline only” is not an arrest.

Crime statistics appear below in this document. In addition to publishing an annual crime statistics report the Facilities Management unit informs the campus community about campus crime in a number of ways, including the following:

- ❖ **Special Crime Alerts.** When circumstances warrant e-mail crime alert notices will be sent to the entire community or announced through our P.A. system or blast e-mail. If necessary printed flyers will be posted and distributed.
